### PROFESSIONAL EXPERIENCE

#### 1998-2022:

Started the dispute resolution practice of a major London firm in Singapore and Jakarta. Subsequently practising as counsel and independent arbitrator involved in international commercial arbitrations, insurance and reinsurance claims and disputes.

# 1986-1998:

- Carrian affair: acting for E&O insurers of international accountants involved in this high profile Hong Kong property scam;
- Acting in the winding up of a Hong Kong insurance/reinsurance company in conjunction with international accountants;
- Appointed as an arbitrator on various insurance and commercial disputes;
- Providing advice on insurance policy wordings to both insureds and insurers.

### 1982-1986:

Practised as a solicitor in the City of London with the firm of Elborne Mitchell. Involved in numerous Lloyd's market problems, regulatory issues, insurance and reinsurance claims, letter of credit and international trade disputes. Notable pieces of work include the following:

- Acting for the state run Brazilian reinsurer in a reinsurance dispute which decided that the method by which insurance business was placed in London with unlicensed insurers was illegal, resulting in legislative amendment in the Financial Services Act 1986;
- Advising the Committee of Lloyd's and Lloyd's underwriters on problems arising from extended warranty guarantees;
- Advising underwriters in a number of major international reinsurance disputes including the seminal case of *ICA v Scor* concerning the effect of follow the settlements and claims co-operation clauses.

### 1981:

Articled in Vancouver, British Columbia, with the downtown law firm of Campney & Murphy. Notable work included:

- Acting for the insured in the case of the Bamcell II which involved the issue of construing the effect of a breach of a warranty clause in a marine insurance policy as a suspensive condition, as ultimately decided in favour of the insured by the Supreme Court of Canada;
- Acting for an insured on hull & machinery and loss of profits marine insurance claims arising out of the grounding of a newly operating fish processing barge which was litigated in both Vancouver and London.
